- Approval of minutes for 2024-03-21 meeting
  - Erin motions to approve; Rebecca seconds
  - Motion passes unanimously
  - Will have minutes from today's meeting to approve via email Julie will send
- Discussion topics
  - o SCOTUS decision update on sending survey to faculty
    - Asked BFC Office about sending survey to faculty; haven't heard back from BFC President yet but hopefully will soon
    - Is it better to wait to send survey until fall? Might not know who to have as panelists without those responses
    - Maybe send survey now and leave it open for a longer time/send again at the end of summer?
    - Send survey and close it middle of May (week after finals week), May 10 – have analysis for end of this committee's work, then pass that along to next year's committee (along with survey if they want to send again) – Brian can help with this through May
      - Useful for FAQ construction
    - Event planning for fall reserve a space? Contact potential panelists?
      - Schedule space for end of fall and then it can be released if not needed
      - Maybe use scheduled space for larger DEI-concerns related event that could include SCOTUS decision but not be just about that
      - Maybe this should be via zoom?
      - Schedule Dogwood Room in IMU (Nov 4 22, some day in there?) - Wednesday, Nov 13, 10am-2pm – Erin can make reservation

- Inclusive Excellence Awards update
  - Nominee reviews completed and 7 awards across 8 award winners (2 people are sharing one award)
  - Rubric was problematic for considering NTT vs TT across all areas of teaching, research, and service – will recommend updating rubric next year based on our experience
  - Fall event planning update need to follow up with OVPDEI –
    Julie will do that follow up
  - Julie will send award announcements to our committee, then BFC Office/OVPDEI, and to award winners – aiming for end of this week/beginning of next week
- o Establishing relationships with DEI leaders April 10 event update
  - Goals/questions for attendees
    - What is your group? What school/dept is it connected to (if it is connected to a school/dept)?
    - What has the group been working on recently?
    - What work/activities are in the future for this group?
    - What is your interest in joining this networking session?
    - How would you recommend we keep this momentum going to stay updated on service group activity on campus (and who to contact for your group)?
  - Follow up survey
    - Lists same questions and adds questions for feedback about event
    - Add question for any additional comments/questions Julie
    - Will send to everyone invited after event occurs Julie
  - Recommend BFC DEIC have ongoing charge to maintain service group list, Rashad confirmed this is best way to manage (rather than OVPDEI office) – email to next year's BFC President (Danielle DeSawal) and include SCOTUS decision activity update as well – Julie/Erin will prepare this
- Year in review
  - Meeting schedule and structure 2-hour meetings once a month is a lot but working portion of meeting helps to get things done; more frequent meetings is a lot on the schedule; it might depend on the people serving on the committee what type of meeting schedule works best
  - Handling BFC charges and current topics (including SB202, Israel/Palestine)
    - Worked on all committee charges and completed work on many of them as well, possibly to detriment of current issues and events that came up

- SB202 and service groups came up quickly and little time to work on anything as a committee; a lot of waiting right now, maybe one school/dept looking at changes to DEI committee name but we are not hearing anything about more widespread DEI committee changes yet; no guidance or recommendations yet from IU Admin/General Counsel/BFC either
- DEI committees are representing multiple viewpoints and perspectives so possibly no changes in terms of SB202
- Israel/Palestine conflict and impact on campus faculty suspension didn't have much involvement from BFC and this committee didn't end up doing much (and no requests for advice from BFC)
- Next year's committee
  - Possibly no co-chair continuing Julie wants to leave guidance/recommendations with BFC President and for next year's committee
  - Student representation needs improvement, hoping for stronger presence from IUSG and GPSG reps next year
