16:17:21 From Alan Bender : On the topic of early grades: The proposal about early evaluations is to do away with the requirement to provide early grades. Again, though, the original rationale for requiring early grades in the first place, especially to freshmen, is that some students may benefit from seeing an actual grade, rather than just receiving feedback along the lines of, say, "you're doing okay." (Some students will understandably wonder "Okay toward receiving what grade? Do I need to step up my game to be progressing toward an A?") Even if there is not any sort of major project due or major exam given early in the semester, instructors could perhaps be expected to have given assignments that can be graded, even if those assignments represent a small part of the final course grade. [... Just trying to provide more rationale for the existing early-grade requirement.]
